**The fund** is established for an unlimited duration.

\*The fund does not hold a license as a fund manager or small fund manager from the Financial Inspection, and the Financial Inspection does not supervise its activities.

### Asset Diversification:

- A) The largest portion of investments is directed into the least risky cryptocurrency assets.
- B) A portion of the capital is traded across different time intervals.
- C) A portion is invested in crypto startups.
- D) A portion is held in the cash reserve.

### Capital Allocation Distribution:


The capital is allocated according to a specific strategy in proportions across positions to minimize the risk of losses.

### Innovative Strategies:

The use of advanced technologies, analytics, and algorithms to identify market opportunities and optimize the investment portfolio. Focus On market Cycles:

The cryptocurrency market has its own patterns, which were originally embedded in the Bitcoin code.

Focusing on these patterns significantly reduces the risk of losses.



## FUND UNIT

Since BitBrave is a mutual investment fund, it means that the investor acquires fund units as an investment asset.

In the future, the investor tracks the profitability of their contribution through these fund units.

- A fund unit is an index of all the fund's assets.
- The price of a fund unit depends on the current value of all the fund's assets, including those listed on exchanges.
- The price of the fund unit always fluctuates.
- The fund's goal is to increase the unit price.



## CONDITIONS FOR PARTICIPATION IN THE FUND

Minimum investment amount: For legal entities: 10 000 EUR For individuals: 5 000 EUR

Fund units can be paid for with fiat currency or cryptocurrency **Redemption of fund units** is possible after 5 years

Early redemption of fund units is allowed

## ADVANTAGES FOR FOREIGN COMPANIES

## The fund's profit tax is 0%:

Since **BitBrave** is legally a fund and is registered in Estonia, it is not subject to corporate income tax.

This means that no tax is levied on your capital while it is invested and reinvested.



## There is no double taxation for foreign companies:

Estonia does not levy tax on income earned by nonresidents from capital gains if the fund decides not to distribute profits.

Additionally, Estonia has signed agreements with many countries to avoid double taxation

## ADVANTAGES FOR COMPANIES

Access to the rapidly growing cryptocurrency and blockchain technology market:

The cryptocurrency market is the fastest-growing market right now, with immense potential.

By investing in the fund, you gain quick access to this market without having to spend years learning it yourself.
